OPEN MEETING

1. Call to Order: With a quorum present the meeting was called to order by Vice Chair, Olivia Johnson at 5:36 P.M.

NEW BUSINESS:

- **1. Teacher Housing Site Prep Bid:** Superintendent Patterson recommended the Board pass a resolution to award contract to Corland Construction and authorize the Superintendent to sign contract documents. - **2. Scoreboard Contract:** Superintendent Patterson presented the Board with a unified Scoreboard Agreement.
