OPEN MEETING

- **1. Call to Order:** With a quorum present the meeting was called to order by Chairman, Sammy Nygard at 5:35 P.M.
- **2.Public Comments:** The students attending the meeting stated they would like to have a Science Fair and a better Library. They also want Friday Frapees to be reestablished and a salad bar in the cafeteria.

NEW BUSINESS:

- **1. Locker Rooms/Restrooms Bids:** Three sealed bids were opened beginning at 2:01 p.m., Thursday, February 24, 2022 with Architect, Durward Sobek attending the bid opening by way of a telephone conference call. A Plus Construction of Culbertson had the lowest bid of \$504,000 for the Athletic Locker Rooms and \$162,000 for the Rest Rooms. Superintendent Patterson, as recommended by Mr. Sobek, recommended the Board award the renovation project contract to A Plus Construction. Olivia made a motion to award the contract to A Plus Construction as recommended by the Superintendent. Motion seconded by Rae Jean. Motion carried 4/0.
- **2. NAFIS Travel:** Superintendent Patterson asked the Board to approve travel to the NAFIS Spring Conference in Washington D.C. for himself and District Clerk, Margie Shanks. Olivia made a motion to approve the travel. Motion seconded by Terry. Motion carried 4/0.
- **3. Hire Para:** Superintendent Patterson recommended hiring Lance Bengochea as a full time Paraprofessional at \$15.00 per hour. Olivia made a motion to hire Lance Bengochea as recommended by the Superintendent. Motion seconded by Rae Jean. Motion Carried 4/0.
- **4. Hire Coaches:** Athletic Director, Milt Apple recommended hiring Jimie Lou Morris as Head Varsity Golf Coach. Rae Jean made a motion to hire Jimie Lou as head Golf Coach as recommended by the Athletic Director. Motion seconded by Olivia. Motion carried 4/0.
