Teacher Leave for college course work

Sunny DeCoteau is pursuing her Master's degree in Education with as an endorsement in Reading with MSU, Bozeman. In order to attend some classes in Bozeman, she will have to miss work days. Currently, there are no provisions in the District Policy Manual or within the collective bargaining agreement that provide for paid Leave for the purpose of attending college courses or professional development trainings. The administration would support such leave so long as it could be preapproved by administration and if sufficient staff

coverage could be obtained. We would want to ensure that such course work or trainings would benefit the District's staffing and/or instructional needs.

Teacher Housing:

Teachers have moved in the units. Only irrigation and sod remain on the to-do-list as well as a few minor issues.

Campus Projects

Still waiting on the electrician to hook up power to the bus gate and handicap doors as wells as fix electrical problems in the SPED room and one of the duplex units. We are also still waiting on the new swings for the playground which are set to ship on the 23rd of this month.

Bathroom & Locker Room Project

Bathrooms are done except for hanging the mirrors, installing the entrance light. The locker room HVAC has been installed, the ceilings have been installed and painted, and tile is close to 50% complete on the walls. The project is still about 2 months away from being finished with a completion goal of November 1st.

The IDEA and Consolidated grants are completed and have been approved by OPI. I will have the Title Support grant completed and submitted before the end of the month.


Board Training

I'm working with Larry to schedule the second round of Board training. Would you like for me to schedule another 2-hour training before one of our upcoming Board meetings?


MASS Conference
