OPEN MEETING

- **1. Call to Order:** With a quorum present, the meeting was called to order by Chairman, Sammy Nygard at 5:31 P.M.
- **2.Public Comments:** Rena Lambert explained the ARP-AIRE Grant that the Tribes received and how a portion of the funds could be used for educational purposes at Brockton School.

NEW BUSINESS:

- **1. Election Resolution:** Chairman Nygard called for a resolution for a trustee election for one seat that will be opening at the end of the current school year. A motion to hold a trustee election by poll at the Brockton School District Office, the only poll location in the District, beginning at noon on Tuesday, May 2nd, 2023 was made by Wilfred and seconded by Olivia.
